Plaintiff seeks damages for personal injuries alleged to have been sustained by him through negligence of the defendant Harry Flaxman, as guardian of his minor son. Judgment was rendered in favor of the defendant, and from such judgment this appeal is taken. [1] No good purpose will be served by a further statement of the facts. After appellant had rested his case on its second count the trial court at the request of appellant's attorney stated that it was not going to give any further instructions to the jury; that a verdict might be directed against appellant on the issue of his contributory negligence, and that it was going to direct the jury to find a verdict against appellant on the second count. The jury was instructed by the court that if the jury found by a preponderance of evidence that appellant was guilty of contributory negligence, the jury would be warranted in finding a verdict in favor of the defendant. The second count of appellant's complaint alleges that the defendant was guilty of negligence in selecting, handling, preparing and selling for use in plaintiff's car an empty gallon can containing a dangerous and explosive substance, knowing such dangerous and explosive substance to be of a type which the defendant should reasonably know was dangerous; that defendant knew the quantity of gasoline in the container, and
