Appellant brought an action against the state to recover damages for personal injuries suffered when he was compelled to abandon his job because of the action of the California Unemployment Insurance Appeals Board (hereinafter called the Appeals Board). Appellant was employed as a prop master for Mack S. Fleck Company (hereinafter called the company). His duties required him to work occasionally on company boats being used on the Bonneville Power Administration Project. The contract to furnish the boats for this project \*186 was awarded to General Dynamics Corp. The contract required the company to furnish certain equipment, including winches and anchors, on each boat, but all of the equipment had to be delivered at a certain port. The company was required to deliver this equipment and the boats at an inland port in the state. Thus, appellant's duties included preparing for and participating in the delivery of boats to and work on the project. The delivery of the boats to the project site was to be made on a weekly basis; each boat had to be berthed in the project, loaded with equipment, prepared for use, and a week later unloaded and returned to the company's facility for storage until its next delivery. There was no work scheduled for any boat on the project between weekly deliveries. On September 25, 1962, appellant was injured and was unable to work. He was certified as being able to return to work on October 22. He advised the company's personnel supervisor that he desired to return to work. The supervisor informed him that the company was unable to operate a boat due to unavailability of the winches and anchors. Appellant conferred with the personnel supervisor and two of the company's officers and then
